

# Privacy Policy iCEBREAKERS GmbH

Thank you for your visit and for your interest in our website. The protection of your personal data is very important to us. By accessing or using the iCEBREAKERS website, you agree to the terms of this Online Privacy Policy, as outlined below. If you do not agree to these terms, please do not access or use this site.

## COLLECTION OF PERSONAL INFORMATION

If you engage in certain activities on this site, you may be asked to provide specific information about yourself by filling out and submitting an online form. It is optional to you to engage in these activities. If you decide to engage in these activities you may be required to provide personal information, such as your name, mailing address, e-mail address, and other personal information.

When you submit personal information, you understand and agree that iCEBREAKERS may transfer, store, and process your information in any of the countries in which iCEBREAKERS is active.

iCEBREAKERS collects this information in order to record and support your participation in the activities you selected. iCEBREAKERS also uses information that you provide as part of our effort to keep you informed about special offers, and other iCEBREAKERS services. iCEBREAKERS is never going to sell or share your information with other companies and third parties.

## PERSONAL DATA

Personal data is information that can be used to discover your identity. This includes your name, address, postal address and telephone number. Information that is not associated with your identity (such as the number of users of a website) is not included. You can use our website without revealing your identity. When you request information, or make other inquiries, we ask for your name and other personal information. Your information will be stored on the servers of the hosting provider Hostpoint, which is located in Switzerland. Access to it is only given to a small group of authorized personnel. These are responsible for the technical, commercial or editorial support of the content and servers. The data which is required to fulfill existing statutory or contractual retention periods (such as invoices) is going to be stored beyond. However, these data are locked and accessible only to few authorized persons.

## **DISTRIBUTION OF PERSONAL DATA TO THIRD PARTIES**

We use your personal information only to answer your inquiries. We do not share the data with third parties without your expressed consent. Only if we are legally obliged to do so or by court order, we will forward your data to authorized third parties.

## **PROTECTION OF MINORS**

Children and persons under the age of 18 should not submit any personal information to us without the consent of their parents or legal guardian.

## **USE OF COOKIES**
